

RELEASE, WAIVER AND INDEMNITY AGREEMENT

IT IS THE INTENTION OF _____ BY THIS AGREEMENT TO EXEMPT AND RELIEVE THE HSRC SPORTS PROGRAM AND FAMILY OF FAITH CHURCH, AND ITS OFFICERS, COACHES, AGENTS OR EMPLOYEES FROM LIABILITY FOR PERSONAL INJURY, PROPERTY DAMAGE, OR WRONGFUL DEATH OF _____ CAUSED BY ANY ACT OF NEGLIGENCE OF THE HSRC SPORTS PROGRAM AND ITS OFFICERS, COACHES, AGENTS OR EMPLOYEES.

For and in consideration of permitting the participant to observe, our use any facility or equipment of the HSRC Sports Program, or engage in and/or receive instruction in any activity or activity incidental thereto, some of which may involve dangers and risk of bodily injury at the HSRC Sports Program, held at Family of Faith Church, in the city of Monee, County of Will, and State of Illinois, beginning on the day of _____, the undersigned parent and/or guardian of the participant, hereby voluntarily and absolutely releases, discharges, waives, and relinquishes any and all loss or damages or actions or causes of action for personal injury, property damage, or wrongful death occurring to the participant as a result of their observing or using facilities or equipment of the HSRC Sports Program or Family of Faith Church, or engaging in or receiving instructions in any activities some of which may involve dangers and risk of bodily injury or in activities incidental thereto wherever or however the same may occur, and for whatever period said activities or instructions may continue.

The undersigned parent or guardian of the participant for him/herself, his/her heirs, executors, administrators, or assigns agrees that in the event any claim for personal injury, property damage, or wrongful death shall be prosecuted against the HSRC Sports Program and Family of Faith Church or their officers, coaches, agents, or employees, the undersigned parent or guardian will indemnify and hold harmless the HSRC Sports Program and Family of Faith Church and their officers, coaches, agents or employees from any and all claims or causes of action by the participant or by any other person or entity, by whomever or wherever made or presented, and under no circumstances will the undersigned parent or guardian of the participant present any claim against the HSRC Sports Program or Family of Faith Church and said persons for personal injuries, property damage, wrongful death, or otherwise, caused by any act of negligence by the HSRC Sports Program or Family of Faith Church and said persons.

The undersigned parent or guardian represent that he/she has read this release, has requested and has been provided with, or has requested and declined advisement on the potential dangers/risks of engaging in the observation, activities, or instruction offered, assumes all risks associated with such dangers and risks, and is fully aware of and understands the terms and the legal consequences of the signing of this release. The undersigned parent or legal guardian intends his or her signature to be a complete and unconditional release of all liability to the greatest extent allowed by law and if any portion of the release is held invalid, it is agreed that the balance shall, notwithstanding, continue, in full legal force and effect.
